GENERAL INFORMATION

1. we respect the right to privacy and care about data security, including personal data. SSL protocol is used at the stage of Registration and browsing the website <https://bitpeak.pl/>.

2. personal data is processed in accordance with the law and the Privacy Policy.

3 The scope of the data we collect:

(a) voluntarily entered personal data at the stage of filling in the contact form (name, e-mail address),

b) cookies stored on terminal equipment (so-called "cookies"),

c) web server logs collected by the hosting operator.

REGISTRATION DATA

1. Personal data (email, name) which are provided by the person filling in the contact form.

COOKIES

3. The Administrator uses personal data for the purposes, on the basis of the premises and for the period of time:

b. the User's consent to the processing of his/her data for the purposes of providing commercial information and responding to his/her queries or on the basis of a legal obligation.

d. possible establishment, assertion of claims or defense against mutual claims of the parties - the legal basis is Article 6(1)(f) RODO i.e. implementation of the Administrator's legitimate interest in the form of assertion of claims and defense against claims related to the Agreement; the data shall be processed for the duration of the Agreement, and after its termination until the fulfilment of the Administrator's legitimate interests constituting the basis for such processing, in particular those related to the prescription of claims arising from the Agreement in which the personal data were collected;

6. The Participant's rights in relation to the processing of his/her personal data: (1) access to his/her data, including confirmation of its processing, (2) obtain a copy of the data and information about its processing (Article 15 of the DPA), (3) rectify inaccurate data or complete incomplete data (Article 16 of the DPA), (4) delete data if the Administrator no longer has a legal basis for the processing or the data are no longer necessary for the purposes of the processing (Article 17 of the DPA), (5) restrict data processing if it is reported that: (a) the data are incorrect - until verified (b) the processing is unlawful and the applicant objects to erasure (c) the Controller no longer needs the data and the applicant needs the data for the establishment, investigation and defense of claims (Art. 18 RODO), (5) data portability, including receiving them in a structured machine-readable format or requesting that they be sent to another Controller (Art. 20 RODO), (6) to object to processing for purposes resulting from the legitimate interests of the Controller, in particular direct marketing and against profiling carried out for these purposes (Art. 21 RODO), (7) to withdraw consent to the processing of personal data in a situation where it constitutes the basis for data processing, which, however, does not affect the lawfulness of processing carried out on the basis of consent before its withdrawal (Art. 7(3) RODO).
